- 4. In case of joint holders attending the Meeting, only such joint holder who is higher in the order of names will be entitled to vote.
- 5. Members desiring any information on Accounts are requested to write to the Company at least one week before the meeting so as to enable the management to keep the information ready. Replies will be provided at the meeting.

- 7. The Registers under the Companies Act, 2013 will be available for inspection at the Registered Office of the Company during business hours between 11.00 am to 1.00 pm on all working days except holidays. The said Registers will also be available for inspection by the members at the EGM.
- 8. The relevant Explanatory Statement pursuant to Section 102 of the Companies Act, 2013 in respect of the special business under item number 1 is annexed.

ITEM NO.: 1

Appointment of Mr. Vipul Singla as a Non-Executive Independent Director of the Company

The Board of Directors vide Resolution adopted on 22.01.2025, appointed Mr. Vipul Singla (DIN: 03596183) as an Additional Director (Non Executive Independent Director) of the Company, pursuant to Sections 149, 152, 161 read with Schedule IV and other applicable provisions of the Act.

In terms of Section 149 and other applicable provisions of the Act and Rules made thereunder, the proposed resolution seeks the approval of members for the appointment of Mr. Vipul Singla as a Non-Executive Independent Director upto the date of Next Annual General meeting not liable to retire by rotation.

The Company has received consent from Mr. Vipul Singla to act as a Director and declaration to the effect that he meets the criteria of independence as provided in sub-section (6) of Section 149 of the Act and also a declaration under Section 164 of the Act that he is not disqualified from being appointed as a Director.
